About the Teacher

Associate Professor Alex Bruno is a trained Political Philosopher with special competencies in teaching, social communication, and human relations. Mr. Bruno holds two Master of Arts degrees: one in Political Science from Florida Atlantic University (FAU) and the other in International Studies from Florida International University (FIU). These degrees were earned in 2016 and 2022 respectively. Bruno also obtained a Bachelor of Arts degree with a major in Philosophy and a Minor in Theatre from FAU in 2015. Raised in a small Minnesota town near the Iowa and South Dakota borders, he attended South Dakota State University as an undergraduate and served in the U.S. Army Special Forces in Vietnam before enrolling at the University of Minnesota, where he received his PhD in 1971.

Plagiarism

- Taking the words or specific substance of another and either copying or paraphrasing the work without giving credit to the source.
- Submitting a term paper, examination or other work written by someone else
- Submitting the same term paper, slightly altered paper, other work, or examination, for more than one course, whether in the same term or another term. This is self-plagiarism.
- Failure to give credit in a footnote for ideas, statements of facts or conclusions derived by another.

- Failure to use quotation marks when quoting directly from another person, whether it is a paragraph, a sentence or even a part thereof.
- Similar and extended paraphrasing of another.

Plagiarism-Use of Artificial Intelligence (AI) Programs

Artificial intelligence programs (AI) such as ChatGPT can craft papers that resemble the work of human researchers. AI has many legitimate uses in business, government, and society. A primary mission of Palm Beach State College is to advance human intelligence, so presenting work completed by AI rather than by the student's efforts is counterproductive and deceptive. Palm Beach State College has state-of-the-art software to detect the use of AI writing. The use of AI directly violates Palm Beach State College's standards for plagiarism, expressly "Submitting a term paper, examination, or other work written by someone else." Students submitting work completed by AI, in whole or in part, without proper citations and explicit instructor permission, are guilty of academic dishonesty and subject to the process and penalties described in the Student Handbook under Academic Policies.

Cheating

Using unauthorized notes, study aids, or information from another student or student's paper on an inclass examination; altering a graded work after it has been returned, then submitting the work for regrading; and allowing another person to do one's work and to submit the work under one's own name or otherwise not following the rules or instruction to gain an advantage. Unauthorized collaboration, the sharing of work or knowledge specific to the completion of a project, quiz, or examination without the permission or knowledge of the instructor, is also cheating. Forgery

Intellectual recording-HB233
