Per 2/17/15 Email from Dr. Pedersen, this action is not necessary. MAT1033 lecture/lab coreqs will remain intact for 20153 and be separated 2016-1 (last offered 20153).		

Justification: This is a transitional action for both these courses so that they can be offered in the summer term without the corequisite lecture requirement prior to being deleted at the end of the summer term with the new configuration of the lecture courses MAT1033C and ENC1101 starting in fall term.)

As you pointed out, only non-exempt students would be required to provide scores or Dev Ed course grades for registration in these courses. It seems this is just the way that the two groups chose to handle the situation presented to them. Plus adding the credit to ENC1101 would throw off all degree credit totals that we offer now since it is a required course of all programs. (MAT1033 only impacts one program directly.)
