### **ITEM 1. REVISION OF LEARNING OUTCOMES AND COURSE DESCRIPTIONS**

*Discussion:* Revisions to learning outcomes and course descriptions for the following courses are needed: ARH1000, ARH2050, ARH2051. ARH1000 course descriptions, learning outcomes, and where best to end Art History 1 and commence Art History 2 were discussed in great depth. Some felt the old outcomes were poorly worded, vague, and out of date, and the changes proposed reflect more accurately the course content and the description/outcomes for each course. With regards to the end/start point in Art History 1 & Art History 2 it was agreed that continuity was needed to prevent issues of students missing out on crucial information.
