expressed the need to update and strengthen the course outcomes.

Data/data source: Dr. Rajcoomar

Action: The cluster updated the outcomes from the course and are listed as follows:

- Assess the essential elements of community health, school health programs, epidemiology, organizations that shape community health, the history of health care delivery systems and contemporary issues affecting the nation's health care system.
- Evaluate current evidence based research of community health initiatives throughout the lifespan of individuals, including maternal, infant, early childhood, adolescent, adult and elderly populations.
- Investigate epidemiologic strategies to reduce burden of disease in the community, community mental health, nutrition, injury prevention, environmental concerns, chronic and infectious diseases.
- Analyze and interpret the distribution of global and cultural disease and health challenges across various communities and the components of health education programs.
- Applying critical analysis skills in developing solutions to local, state, national and global community health issues.

The updated HSC 2204 Community Health course learning outcomes will be submitted to the curriculum committee by Dr. Rajcoomar for consideration at the November curriculum committee.
