ITEM 1 New Faculty Introduction

Discussion: Cluster members were introduced to our new Faculty member at LW campus Professor George Stoupas

ITEM 2 Review Learning Outcomes on PSY 2012 General Psychology Syllabus

Discussion: Cluster members were reminded to review PSY 2012 course learning outcomes, and if necessary update them in the syllabi of their General psychology classes

ITEM 3 Feedback from publishing representatives regarding the 2015 textbook adoption process

Discussion: Dr. Andrew Blair read feedback from the majority of publishing representatives who participated in the 2015 textbook adoption for PSY 2012 General Psychology, DEP 2004 Human Growth and Development and DEP 2102 Child Growth and Development. Overall, the feedback was exceedingly positive with two of the representatives reporting that the process was "very good, fair, and equitable," and that it was "the most organized committee, or cluster that I've had the pleasure of working within my four years as a publisher's representative." Dr. Blair reported to the cluster that the feedback from the Cengage representative would be reported on in the next cluster meeting.
