Welcomed faculty to this academic year, and introduction of the new faculty member at PBG campus, Dr. Ted Cascio.

AGENDA ITEM #2

The textbook adoption process for PSY 2012 General Psychology, DEP 2102 Child Growth and Development, & DEP 2004 Human Growth and Development classes

Dr. Blair and Dr. Arbona reviewed publisher representative-suggested books for the 3 courses and it was decided that all the selected books will be sent to all the full-time faculty for their evaluation.

Publisher representatives will be invited to present on the books chosen. The meetings will be scheduled on Fridays in the coming months and all the voting faculty are expected to attend. Cluster discussed reviewing criteria for voting and possible voting procedures.

Dr. Anderson presented the argument that the population on campuses vary and she wanted to know if the selection of the textbooks could be based on the characteristics of the students of each campus.

As a cluster, do we have the power to decide if each campus could select a different book for their part-timers? Need to consult with Associate Dean Caldwell.

Professor Diaz suggested the idea to look at the "Free course ware" site to see if we could do what the Sociology cluster on the PGA campus has done, that is get books that are free for students. Some professors agreed while others disagree because they will like to have publisher representatives that will provide necessary support service.
