ITEM 3. Update on Current Events in T & I

Discussion:

Assoc. Dean Reeder shared that we are in the process of becoming accredited or reaccredited in Automotive and Diesel for NATEF, Welding as an AWS ATF, PHARA accreditation for HVACR, and have completed FAA Part 141 compliance for Aeronautical Science. Rick also noted that we are launching our new Security and Automation System Technical program this fall, and we will be launching Facilities Maintenance in the spring.

Discussed that all PSAV daytime programs have full enrollment with a wait list, and that we are trying to obtain additional space to continue growing our programs. Employers are standing by to hire our graduates as they complete programs.

Employees have been completing training also, Josh Magwood and Mark Beilen completed AWS QC1 & 5, Raymond Julmiste in Machining received four NIMS Level 1 certifications, and Sandi Barrett is now a MSSC-CPT certified instructor.

Dropping students for non-payment has become an issue with PSAV classes, as classes fill up and those who are ready to enroll **and** pay cannot. Discussed suggesting that the drop date for non-payment be moved out to 2 weeks before the start date. Cluster vote was held

and all approved with exception of one abstaining vote. Assoc. Dean Reeder/Lynn Highsmith will take this forward.

Tracking student employment is an important follow up/closure regarding graduates from each program area. Rick asked that each program develop a method of capturing the name and location of employers who hire our students. A suggested way would be to download the student names from the final module roster into a spreadsheet, and then add columns for employer name, location, and date student was hired. The report can be save for the instructor files and a copy forwarded through Program Directors to the Associate Dean's office. Then, we can forward this information in a consolidated fashion to Karen Lippe who is the person who does the reporting to the state on behalf of the college.

The Welding department underwent a significant project funded by Facilities that included ceiling to floor cleaning, painting, polishing and re-striping of the floors. This task was spearheaded by Tom Lewis and assisted by Josh Magwood and Mark Beilen.
