A. Business and Office Administration

1. AS to AA Conversion

<u>Revised Courses</u>	Effective May 2017 (20173)	
MNA2100	Human Relations in Business (Update from "AS" to "AA")	3

Justification:

Human Relations in Business (MNA2100) is currently required for the AS in Business and the CCC for Business Specialist designation. I am requesting that this course be allowed as an AA elective similar to that of Fundamentals of Entrepreneurship (ENT1000), Managing an Entrepreneurial Enterprise (ENT2112), Planning an Entrepreneurial Venture (ENT2010), Principles of Marketing (MAR2011), Introduction to Business (GEB1011), Business Law 1 (BUL2241), and Business Law 2 (BUL 2242). There are 4 reasons for this request:

1) Per Florida Department of Education Statewide Course Numbering System (http://scns.fldoe.org/scns/public/pb_inst_course_dtl.jsp), several colleges offer MNA2100 within the A.A. degree, including:

- 1) North Florida Community College

- 2) Tallahassee Community College
- 3) Miami Dade College (as MNA2120)

2) Current students who are seeking the AA degree are highly interested in taking this course in furtherance of their AA degree, which supports the completion agenda. Students have indicated that they want to take this course and would find it highly valuable, but decide not to do so because it is indicated for AS only and therefore does not help them with financial aid and/or completion.

3) This course is incorporated into a 12-credit Business Specialist College Credit Certificate (<http://www.palmbeachstate.edu/catalog/current/degrees-programs/business/business-specialist-ccc.aspx#tab-2>), which would enable students to earn a CCC as a completion as they pursue an AA degree. The other three (3) courses are AA classes.
