<u>Justification</u>: The State of Florida is requiring that AS degree programs be modified and limited to exactly 60 credit hours. Currently, the AS Accounting Technology degree includes 64 credit hours. To reduce the number of credits to 60, the cluster has made the following changes: 1) Eliminated HSC2100, 2) Added three SLS classes which focus on career assessment and information as a course selection option. The Cluster believes that the addition of the SLS classes will help students assess their career options in the numerous areas of Accounting. In addition, the Cluster believes that these courses will help students choose not only between the focal points in accounting, but choose between employment at large, medium, or small companies. Therefore, the curriculum in these courses can help to identify advantages and disadvantages which help each student choose an environment which fosters their own individual success. Also, the cluster believes that this will help with retention and completion as the students will gain a clearer picture of accounting as a career.

**Discussion:** Robin D'agati gave an overview of the changes to the Accounting Technology AS required by the DOE mandate to reduce the program to 60 credits. Dropping the General Educations credits from 18 to 15 credits and adding career and job search courses to match the 60 credit limit were two actions to trim and strengthen the competencies of the degree. SLS1501 was added as an option for the course so that students who had already taken the course as new associate degree students would be able to use it as part of this degree. It was asked if the fact that this course was 3 credits would be a problem for students on financial aid since it would put completion over 60 credits and Amy McDonald, College Registrar, indicated that as long as it was listed in the program catalog listing and was a choice for students rather than the only selection, this would satisfy financial aid requirements

Justification: ENT 2010 and ENT2112 are current AS courses required for the AS & CCC for Business Entrepreneurship. The Business Cluster is requesting that these course be allowed as AA electives similar to that of Fundamentals of Entrepreneurship (ENT1000), Introduction to Business (GEB1011), Business Law 1 (BUL2241) and Business Law 2 (BUL 2242). There are four reasons for this request: 1) these courses are almost exactly the same as those offered by Florida State University at the "2000" level, supporting their transferability. 2) Current students who are seeking the AA degree are highly interested in taking these courses in furtherance of their AA degree, which supports the completion agenda. Students have indicated that they want to take these courses and would find them highly valuable, but decide no to do so because they are not immediately transferable and therefore does not help them with financial aid and/or completion. 3) These courses are incorporated into a 12-credit College Credit Certificate which would enable students to earn a CCC as a completion as they pursue an AA degree. 4) No changes to the course curriculum are otherwise required, so this provides attractiveness to students seeking a transfer degree, while still providing critical instruction to those students seeking an AS and/or CCC. The Business Cluster minutes support this action. BE AS- The current program course total credits is 64, which has been mandated by DOE to be reduced to 60 credits. No current courses are going to be deleted, nor are any courses going to need to be created or have any changes to the course dictionary record, as all courses to be retained are in other programs. The additional goal is to allow students additional options using preexisting courses so as to enhance opportunities for completion and overall student success. CCC- This Entrepreneurship CCC program provides invaluable skills for practical career applications across all disciplines, in that it helps students think critically about how to add value to the organizations to which they belong in order to enhance career prospects. The proposed change, while keeping the existing the existing learning outcomes in this CCC, would allow this CCC to be earned by students pursuing their AA degree as well as those pursuing the AS degree. The overarching goal is to allow students additional options using preexisting courses so as to enhance opportunities for completion, flexibility, and overall student success.

**Discussion:** William Paczkowski reviewed the three major changes being done to the Business Entrepreneurship AS and CCC to comply with the FLDOE reduction in credits to 60 credits. This action included converting two courses to AA designation and making course substitutions so that the certificate can be taken by students who planning on completing AA degrees and transferring to four year schools. Amy McDonald, College Registrar, pointed out that the courses being converted to AA courses are offered at FSU, FSW and St. Pete but not at our main feeder school FAU, so students should be carefully advised before enrolling in the course depending on what school they plan to transfer to.

Justification: HSAS -General Changes- This curriculum change is a result of a State requirement to reduce AS degree programs to 60 credits. Human Services General will be reduced from 65 credits to 60 credits. To accomplish this, four current courses will be combined into two "C" courses. HUS 1850 (3 credits) will be combined with HUS 1850L (3 credits) to create HUS 1850C (3 credits), HUS 2851 (2 credits) will be combined with HUS 2851L (3 credits) to create HUS 2851C (3 credits). The program description, content, and outcomes will not change as a result of this curriculum revision. A second change in the Human Services AS degree program will be to add a third course option to GEY2000 Gerontology or HUS1424 Counseling the Chemically Dependent Person--CLP2140 Abnormal Psychology. Cluster members agree that these three options would give students a better choice based on their interest and career path. After reviewing the State Standards, it was determined that this would not have an affect on how the program addresses the Standards. HS CCC-General This curriculum change is a result of a State requirement to reduce AS degree programs to 60 credits and the CCC degree programs to 18/18/24 (General/Youth Dev/Addictions). The HS General CCC will be reduced from 27 to 18 credits, a reduction of 9 credits for the CCC. For the CCC, the revised course, HUS 1850C, will be moved from the CCC to the AS degree. This will reduce the CCC by 6 credits. The program will move one other course from the CCC to the AS degree to complete the reduction to 18 credits for the CCC (GEY2000 Gerontology or-HUS1424 Counseling the Chemically Dependent Person). The program description, content, and outcomes will not change as a result of this curriculum revision. HS-AS Addiction Human Services Addictions AS degree will be reduced from 73 credits to 60 credits. To accomplish this, the separate lecture/lab fieldwork/internship courses will be replaced with the combined "C" courses thus reducing the program by 5 credits. To reduce the program by an additional 8 credits, the faculty will eliminate HUS 1356 (1 cr.), HUS 1400 (2 cr.), and HUS 2320 (2 cr.) from the program and College and add these competencies to other courses. They will also eliminate HUS 2308 (3 cr.) from this program and move those theories to another course. The program description, content, and outcomes will not change as a result of this curriculum revision. HS CCC-Addiction The Human Services Addictions AS degree program will be reduced from 73 credits to 60 credits; the CCC will be reduced from 39 to 24 credits, a reduction of 15 credits for the CCC. To accomplish this for the CCC degree, the faculty will move one revised course, HUS 1850C (previously HUS 1850/L), from the CCC to the AS degree. This will reduce the CCC by 6 credits. They will eliminate several other courses from the Addictions CCC program to reduce the CCC another 9 credits: HUS 1356\* (1 cr.), HUS 1400\* (2 cr.), HUS 2308\*\* (3 cr.), and SYG 2000\*\*\* (3 cr.). Competencies from these eliminated courses will be moved to courses remaining in the program. The program description, content, and outcomes will not change as a result of this curriculum revision. \* These courses will be eliminated from the program AND the College. \*\* This course will be eliminated from the Addictions program. \*\*\* This course will be moved from the CCC to the AS degree program. HS AS-YD Human Services Youth Development will be reduced from 65 credits to 60 credits. To accomplish this, the separate lecture/lab fieldwork/internship courses will be replaced with the combined "C" courses thus reducing the program by 5 credits. The program description, content, and outcomes will not change as a result of this curriculum revision. A second change in the Youth Development AS degree is to replace HUS 2308 Psychotherapy with CLP 2140 Abnormal Psychology, CLP 2140 contains more appropriate content for this student population and will give them a better understanding of various disorders they may encounter in their professions such as, depression, anxiety and learning disorders in children, coworkers and even parents. HD YD CCC For the Youth Development CCC, the faculty will move the HUS 1850/L course (revised to HUS 1850C) from the CCC to the AS degree program only, thus reducing the CCC by 6 credits. Additionally, we will move EDF 1030 and HUS 1203 from the CCC to the AS degree only, completing the reduction of the CCC from 30 credits to 18 credits. The program description, content, and outcomes will not change as a result of this curriculum revision.

**Discussion:** Suzanne Duffy and Susan Caldwell reviewed the changes being made to the Human Services offerings to meet the changes required by the FLDOE. These changes trim the AS programs to 60 credits and the credit certificates to 24 (Addiction) and 18 (HS General and Youth Development). They also reduce duplication of competencies in the offerings and in the case of Addictions, better meet the state requirements for CAP certification.
