ITEM 3: New placement test

**Discussion:** Gail Burkett reported that the new state placement exam (PERT) is being implemented

this week at two institutions, with implementation planned here for next summer. She and Janette Campbell previewed the plan about two years ago; Gail has remained involved throughout the process. She reported that the test bank items are good, but

raised concerns about the cut-off scores. At present, there is no way to use PERT to determine placement above college algebra so the cluster may want to begin thinking about an internal secondary test or diagnostic. The College has no intention as of now to use one. Gail also reported that the state is also heavily reviewing implementation of modular course-work in developmental math.

**Action:** The cluster is encouraged to begin consideration of a secondary means of placement for

upper level courses.

ITEM 4: New workshops introduced in Lake Worth campus math lab

**Discussion:** Dana Hamadeh reported that the LW Math Lab has recently developed a series of topic-

based workshops for students in all levels. The workshops are called SwIM, which stands for Supplemental Workshops in Mathematics. Schedule and topic reminders are being

emailed to instructors on the LW campus each week.

**Action:** Lake Worth instructors are encouraged to remind their students of workshop availability.

ITEM 5: Math Awareness Week

**Discussion:** Sue Hitchcock spoke on behalf of Ana Porro, reminding the cluster about math Awareness

Week. It is not currently scheduled, but events in past years have been held on all

campuses during the first week in April.

**Action:** Cluster members are encouraged to consider what they might contribute in the way of

presenting or promoting events to students.
