## ITEM I. SLC Presentation on ENC0017 Lab Component.

Discussion: SLC Lab Presentation – the SLC learning specialists presented a lab proposal for

ENC0017. After discussion, we opted for a lab with four deadlines. For each deadline, students will complete one reading assessment (a short-answer assessment based on a reading in Reflections) and one writing assessment (taking a paper to the lab for one-on-one review). ### ITEM II. Roundtable Report – Elizabeth Wilber

Discussion: Elizabeth Wilber talked briefly about the roundtable hosted by St. Petersburg College-

Clearwater on September 20, 2013. Martha Campbell organized and chaired the discussion. The following colleges presented their plans to address the changes due to the above two bills: College of Central Florida, Hillsborough Community College, Palm Beach State College, Santa Fe College, State College of Florida, and St. Petersburg College. The purpose was to begin a discussion of what schools were doing, how the changes were going, and sharing data on evaluating those changes. The sentiment echoed by numerous colleges is that everyone needs to be involved--faculty, administration, financial aid, student services, etc. because these changes in dates and length of terms will affect everyone. Many of them have some sort of cross-functional team comprised of advising, financial aid, and dev ed and

credit faculty.

Discussion: Rita gave a quick summary of the presentation at the Pearson

Developmental Education Forum in Orlando. Judith Bilsky provided a brief 5-year history of developmental education expenditures and enrollment. And, she examined the impact of

SB1720 and the challenges ahead. She urged colleges to follow the state's template, adhere to the guidelines, and to be thorough. Furthermore, she emphasized that funding would be withheld if the plan was not submitted on time. Representatives from Miami Dade, St. Pete, and Edison discussed several new initiatives. Miami Dade is offering a boot camp, modularized instruction, compressed courses, and co-requisites. St. Pete and Edison are offering compressed dev ed courses and also linking dev ed with credit courses 8wk/8wk.
