## ITEM 5. College Item – Assessment Cycle

Discussion: Cluster thoroughly reviewed and discussed the data collected in the fall of 2014 for our selected embedded assessment of the SPC 1017 learning outcome related to communication anxiety (Demonstrate how to effectively manage communication anxiety). We (1) recommend a competency benchmark for the selected SPC 1017 outcome and (2) our plan for administering the fall 2014 assessment again in fall 2015.

Data/data source: General Education Embedded Assessment Results, collected and reported in fall 2014 by faculty/adjuncts, complied by IRE; assessment instruments as selected by faculty; General Education Embedded Assessment Spring 2015 Updates, IRE data on learning outcome.

Action: A motion was made by Steve Frishman and seconded by Lori Crane to recommend a competency standard as - 70% of SPC 1017 students will score a 3 (average) or higher on

the learning outcome for communication anxiety. The motion also states that in order to maintain consistency and reliability of the data no changes will be made to how we administer the assessment at this time. Changes to our process will be examined during the

next assessment period.
